PURPOSE:

To certify the form of the ballot for the 2009 Orange City general election.

BACKGROUND

Sections 4.04 and 4.05 of the City Charter provide for a procedure and timeframe to inform the Supervisor of Elections of the language to appear on the ballot for any City election.

In accordance with the provisions contained in the City Charter, Resolution No. 561-09 certifies the form of the ballot by identifying the names of those candidates who successfully completed the requirements for qualifying for the Orange City general election to be held on September 22, 2009.

RECOMMENDATION

It is recommended that the City Council approve Resolution No. 561-09 certifying the form of the ballot for the Orange City general election to be held on September 22, 2009.

RESOLUTION NO. 561-09

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, PURSUANT TO SECTIONS 4.04 AND 4.05 OF THE CITY CHARTER LISTING CANDIDATES AND CERTIFYING THE FORM OF BALLOT FOR THE GENERAL ELECTION TO BE HELD ON SEPTEMBER 22, 2009, REPEALING ALL RESOLUTIONS IN CONFLICT HERewith AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Sections 4.04 and 4.05 of the Charter of the City of Orange City, require that the City Council shall list candidates for Council Member and shall certify the form of ballot to the Supervisor of Elections; and,

WHEREAS, General and Run Off (if necessary) Elections were called for in Resolution No. 551-09 for District 4, 5 and At-Large Council Member; and

WHEREAS, No one race had more than two qualified candidates, therefore, a Run Off Election will not be necessary; and

WHEREAS, at the close of the legal qualifying period as identified in the City Charter and State Statute, the candidates listed below have fulfilled the requirements necessary to qualify to have their name placed on the ballot for the 2009 Orange City General Election:
