RESOLUTION NO. 656-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, PURSUANT TO SECTIONS 4.04 AND 4.05 OF THE CITY CHARTER LISTING CANDIDATES AND CERTIFYING THE FORM OF BALLOT FOR THE RUNOFF ELECTION TO BE HELD ON NOVEMBER 8, 2011, REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Sections 4.04 and 4.05 of the Orange City Charter require that the City Council shall list candidates for Council Member and shall certify the form of ballot to the Supervisor of Elections; and,

WHEREAS, A General Election was held in the City of Orange City September 13, 2011; and

WHEREAS, the election results as certified by the Orange City canvassing board showed that no one candidate in the three-way race for Orange City Mayor received the required majority of votes to win the election; and

WHEREAS, A Runoff Election between Harley Strickland and Tom Laputka, the top two candidates, must now be held in accordance with Section 4.03 of the Charter

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA:

SECTION 1. A runoff election for the position of Mayor of the City of Orange City will be held on November 8, 2011 in accordance with Section 4.03 of the Orange City Charter.

SECTION 2. That the two candidates who will appear on the ballot in a runoff election for the office of Mayor of Orange City are Harley Strickland and Tom Laputka.

SECTION 3. The ballot for the runoff election shall list the candidates for Mayor as listed below:

MAYOR
Tom Laputka
Harley Strickland

SECTION 5. That the City Clerk shall send a copy of this Resolution to the Supervisor of Elections, Volusia County, Florida, as certification of the form of the ballot for the election set forth herein.

SECTION 6. That all Resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed.

SECTION 7. This Resolution shall become effective immediately upon its adoption.
