

RESOLUTION NO. 650-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, ADOPTING A REVISED FEE SCHEDULE FOR BUILDING PERMIT FEES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Orange City adopted Ordinance No. 394 on June 28, 2009 which provides that the Fee Schedule for Building Permit Fees may be revised by resolution; and

WHEREAS, the City of Orange City now finds it necessary to revise the Building Permit Fee Schedule; and

WHEREAS, the City Council wishes to revise and update the Fee Schedule for Building Permits as set forth in Exhibit A” of this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORANGE CITY, FLORIDA, AS FOLLOWS:

SECTION 1. That the City Council of the City of Orange City adopts the change to Exhibit “A” attached hereto and identified in underline and by this reference incorporated herein for all intents and purposes.

SECTION 2. All resolutions or parts of resolutions in conflict herewith be and the same are repealed.

SECTION 3. If any section, part of a section, paragraph, clause, phrase or word of this resolution is declared invalid, the remaining provisions of this resolution shall not be affected.

SECTION 4. That this resolution shall take effect immediately upon its adoption by the City Council of the City of Orange City, Florida, and approval as provided by law.

1. **Plumbing**

New Structure, Additions & Alterations - \$50.00 plus \$.70 per thousand total valuation - \$50.00 minimum

2. **HVAC**

New Structure, Additions & Alterations - \$50.00 plus \$.70 per thousand total valuation
- \$50.00 minimum

3. **Electric**

New Structure, Additions & Alterations - \$50.00 plus \$.70 per thousand total valuation
- \$50.00 minimum

4. **Gas**

New Structure, Additions & Alterations - \$50.00 plus \$.70 per thousand total valuation
- \$50.00 minimum

5. **Mobile Home Set-up Fee**

New Structure - \$75.00 includes building only. Electrical, mechanical and plumbing separate permits as needed. (Does not include accessory structures.)

6. **Demolition Fee**

\$80.00 for the first \$20,000 of structure value and \$5.00 per \$1,000 of structure value thereafter.

7. **inspection Fee** - \$50.00 first, \$60.00 second, \$75.00 third (for the same list)

8. **Double Fee required for all work started prior to permit issuance.**

9. **Failure to call for inspection - \$50.00**

10. **Plan Review Revision - \$100.00**
