- A. **Resolution No. 953-19-** A resolution of the City of Orange City, Florida, relating to the provision of street lighting services, facilities, and programs throughout the Briarwood south street lighting assessment area; estimating the cost of street lighting services, facilities, and programs to be assessed for the fiscal year commencing October 1, 2019; determining that certain real property will be specially benefitted thereby; establishing the method of assessing the street lighting service cost against the real property that will be specially benefitted thereby; directing the City Manager to prepare or direct the preparation of a preliminary assessment roll based upon the methodology set forth herein; establishing a public hearing to consider imposition of the proposed street lighting assessments and the method of their collection and directing the provision of notice in connection therewith; providing for severability; and providing an effective date.
